
# **ROLLOVER SNAPSHOT (D-2)**


### **Nifty Rollover Analysis**

- 1. The rollover for Nifty Futures advances as **50%** positions got rolled over to the January series as on **D-2** days prior to expiry.
- 2. The current rollover is higher as compare with its three months average of **37%** respectively observed at the same point prior to expiry.
- 3. The rollover cost for long rollovers closed at **63 bps.**
- 4. The total open interest in Nifty Futures across all contracts stands at 12.65Mn shares.





# **Banknifty Rollover Analysis**

- 6. The BankNifty December expiry rollover is higher at **54%** on **D-2** compared with **44%** on same day of previous expiry.
- 7. BankNifty Futures OI stands at **2.68mn** shares as against the OI of **3.40mn** shares on **D-2** of the last series.
- 8. The rollover cost for long rollovers closed at **52** bps.
- 9. The current rollover in BankNifty is higher as compare with its three months average of 41% respectively observed at the same point prior to expiry.


